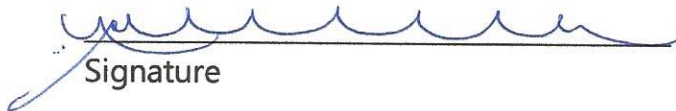

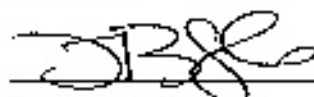

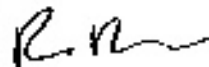

Dear Neighbor,

I have had my house on the market for over 8 months. Potential buys want to tear it down to build a home with larger rooms and more modern facilities. I have had multiple qualified buyers view the property. The problem is, it is listed as an historic property with Miami Beach. In 2007 the Beach offered reduction in taxes for ten years if a resident would list their home. I never completed the paperwork and received no reduction in taxes, but the city still considers it designated. Even though the original house has been added on to over the years (Maid's cottage in 1955, garage in 1989 and a downstairs master suite in 2007) it was given historic designation. The original cottage with 2 bedrooms upstairs and living area down can't even be seen from the road.

Personally, I am having a tough time keeping the house up. My ninety-three year old husband is in memory care and unable to help. I have the additional expense of paying for assisted living.

No one has offered to buy the property because of the limitation of Historic Preservation unless the designation is removed. So, I am house rich and cash poor.

I do have an offer to buy the house, but *only* if the designation is removed. A hearing is scheduled for May 9th, 2023
