XI. MODIFICATIONS OF PREVIOUSLY APPROVED BOARD ORDER

1. HPB24-0626 a.k.a. HPB20-0379, **2901-2911 Indian Creek Drive**. An application has been filed requesting modifications to a previously issued Certificate of Appropriateness the total demolition of two existing buildings, the renovation, restoration and relocation of one existing building, the construction of a detached residential addition and multiple variances from the required pedestal and tower setbacks and to exceed the maximum projection allowed in required yards. Specifically, the applicant is requesting approval for the total demolition and

reconstruction of the building previously approved to be retained and relocated on the site.
