Preliminary Investigation

Upon receipt of the assignment, we conducted comprehensive research associated with the target location utilizing the provided identifying information. Records indicate the Vendome Nightclub can be located at 743 Washington Avenue, Miami Beach, FL 33143. The nightclub can be described as a white building facing Washington Avenue.

Mapping software was employed to locate the nightclub's address prior to beginning surveillance efforts and for assisting with logistical matters.

Valdes Investigation Group was tasked with documenting any line queuing being conducted or allowed by the nightclub that clearly obstructs the pedestrian walkway or right of way.

Investigative Narrative

Surveillance: Day 1

Date: Thursday, October 31, 2024

Times: 11:05 pm- 3:13 am

At approximately 11:05 pm, the Investigator arrived at the area of Vendome Nightclub located at 743 Washington Avenue, Miami Beach, FL 33143. Upon arrival, the investigator observed there were stanchion barriers in front of the nightclub, with two male employees/bodyguards that stood behind the stanchion barriers. In front of the stanchions, there were four other employees dressed in black standing on the sidewalk. They were observed walking back and forth from the stanchions. There was also another male with a black t-shirt that stated "Valet" observed speaking with the employees. A few individuals walked on the sidewalk and there were others standing in the border of the sidewalk that led to the street.

As the night progressed, there were individuals observed gathering on the sidewalk in the area prior to Vandome and the area after. In front of Vandome, the men dressed in black/employees gathered on the sidewalk and spoke. Guests were observed waiting to be let in.

After 12am, the investigator documented an increase in the number of individuals walking and waiting on the sidewalk.

At approximately 12:26 am, an unidentified male dressed in black is observed directing individuals to move to the side to make a uniform line. Police officers were observed on the sidewalk in front of the nightclub as well.

On various occasions, employees could be observed directing individuals to move out of the way, directing them to either go inside or move to the side.

After 1 am, the volume of individuals and vehicles arriving and parking on the side of the street in front of the nightclub grew larger.

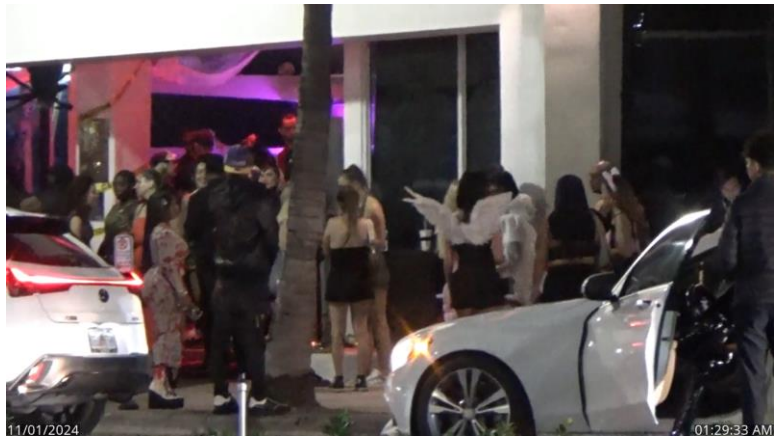
Between 1am and 3 am, the sidewalk and street were very populated with individuals and vehicles.

At approximately 3:13 am, surveillance efforts were terminated.
