Hello Roberto,

It was a pleasure to speak with you. To recap, the tree disposition plan comment does not apply to the DRB plan as the development is specific to LOT 5 and has an independent tree disposition plan (whereas the PB application tree disposition plan has one plan for both lots) in which the #11 Gumbo Limbo exists on LOT 4. So, no changes necessary to the tree disposition for the DRB application.

Second, the required lot and street tree specifications need to show the canopy spreads at time of planting (6-foot min.) on the DRB plans

Last, all of the large shrub/small trees also need to include the spreads at time of planting in the specifications (4-foot min.) on the DRB plans.
