

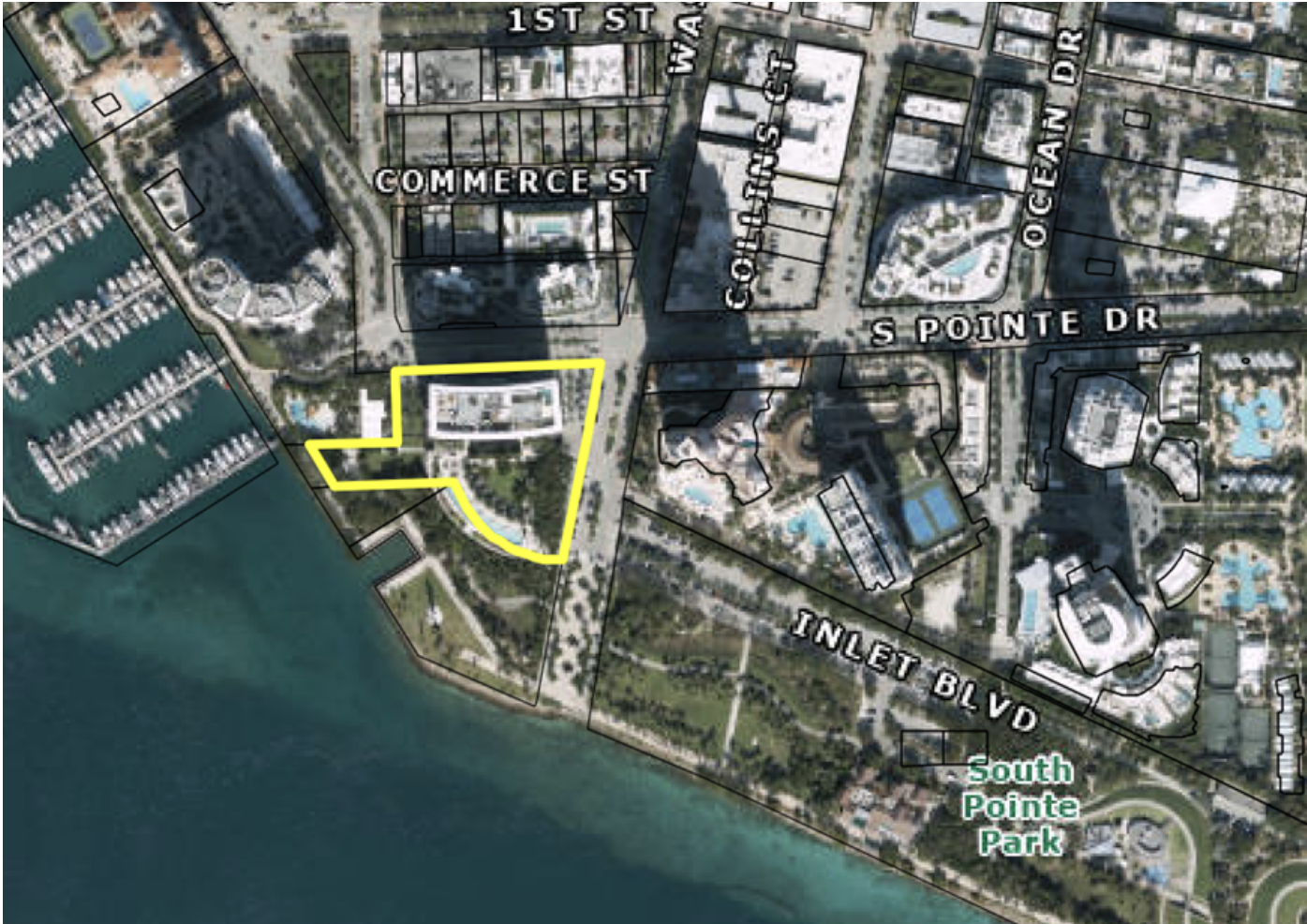

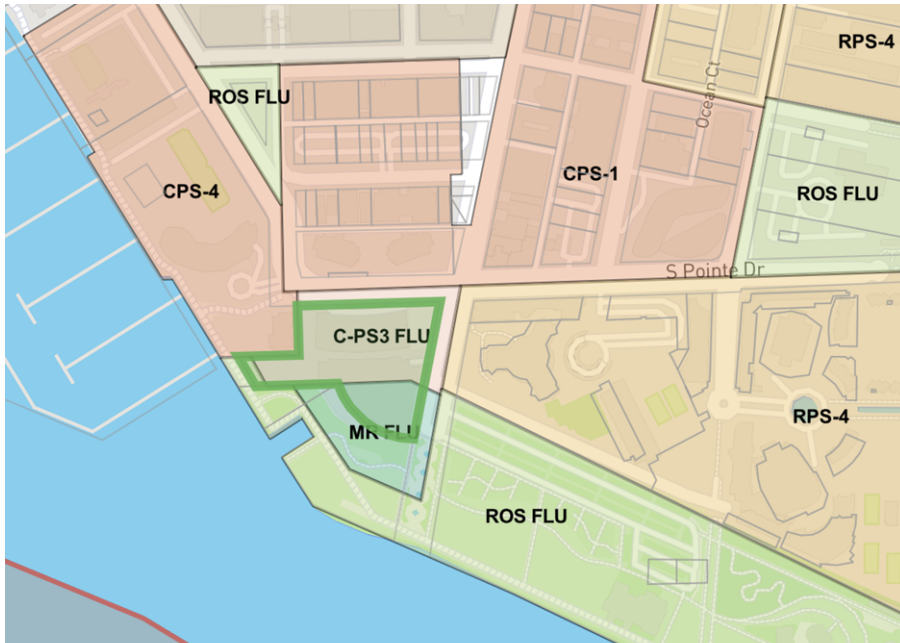

Property Location Map

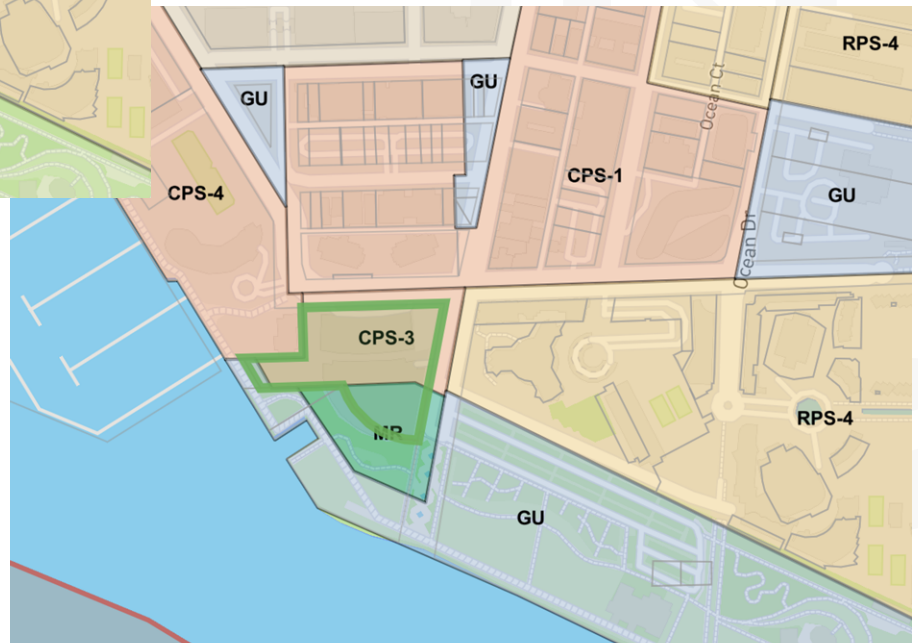


Property Aerial

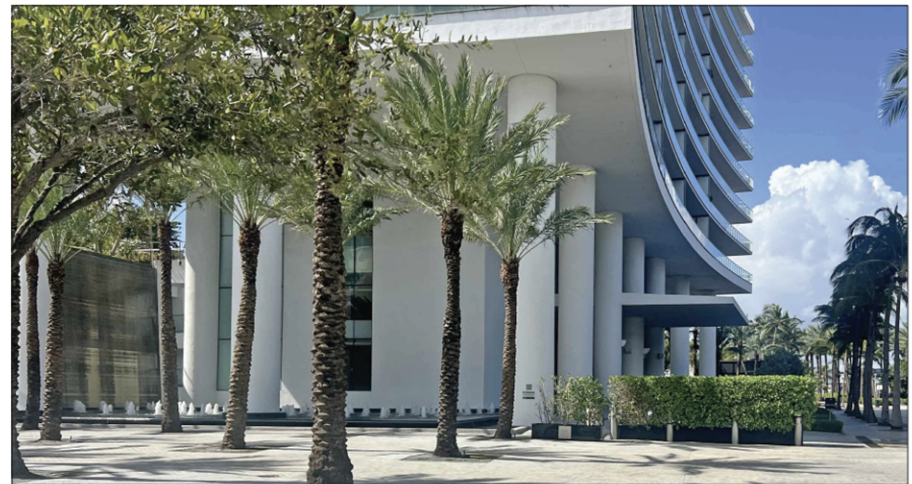

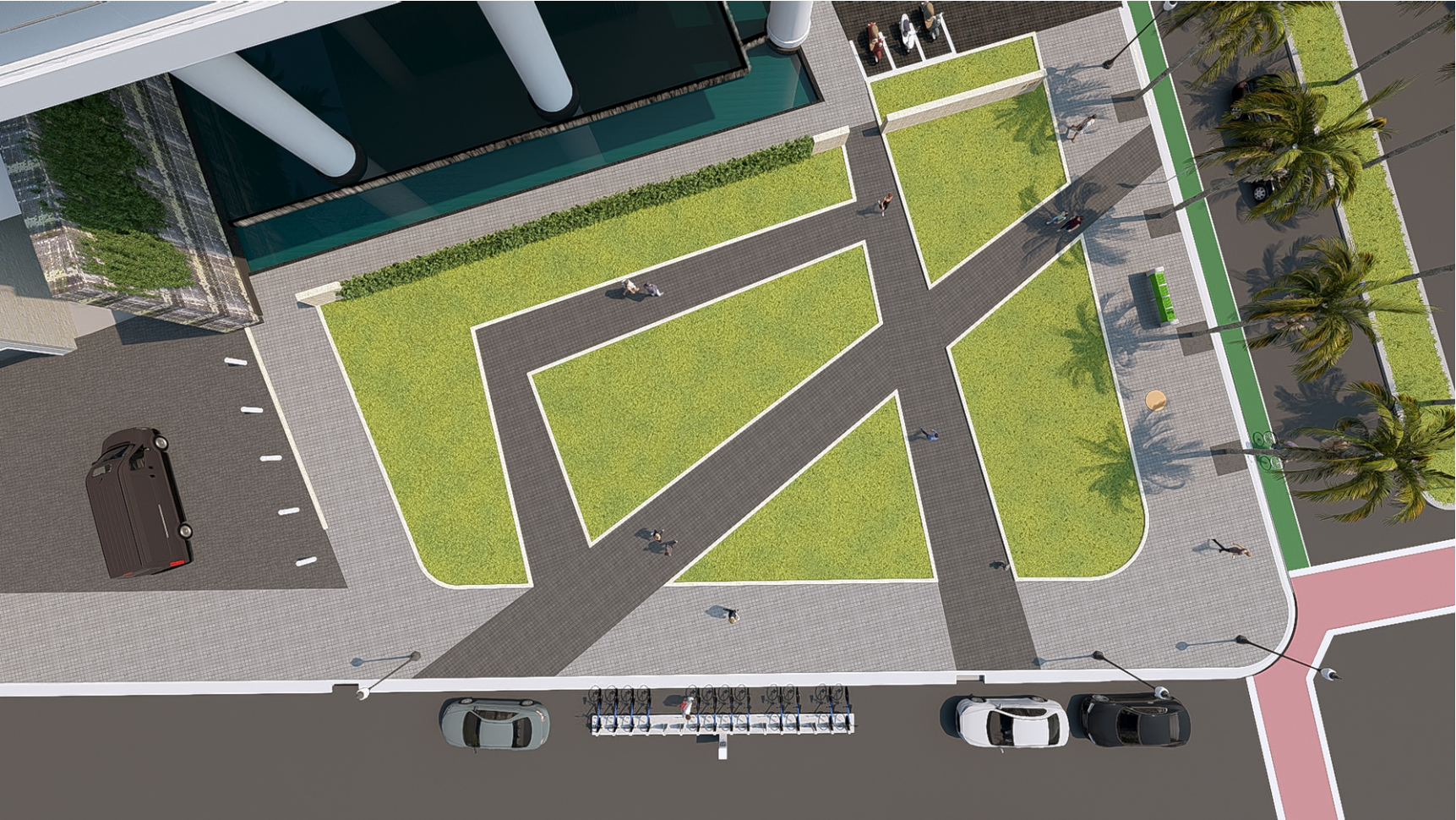


- Manage stormwater runoff and reduce Urban Heat Island Effect
- Recycle existing granite pavers to reduce material waste, demolition and transport

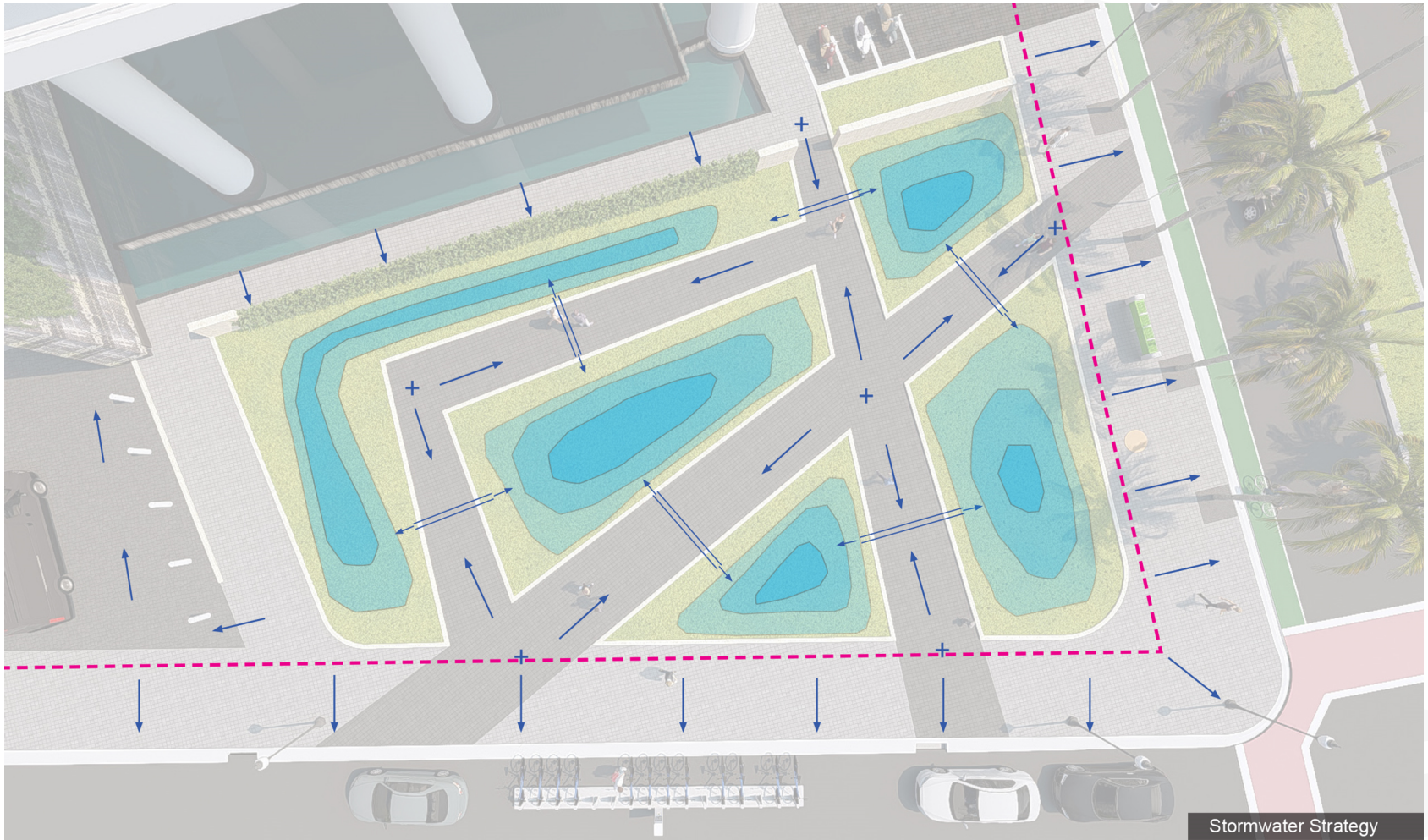

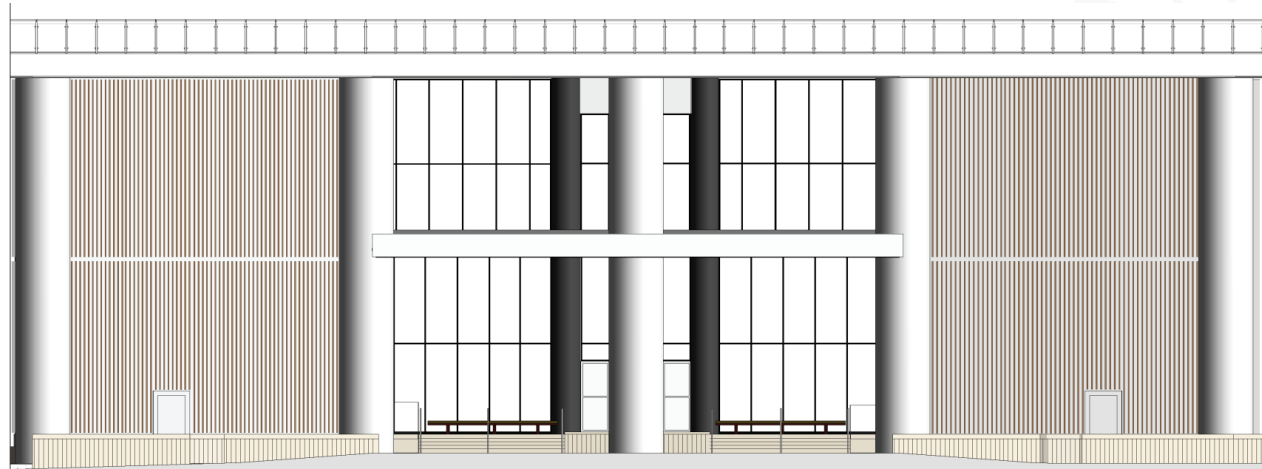

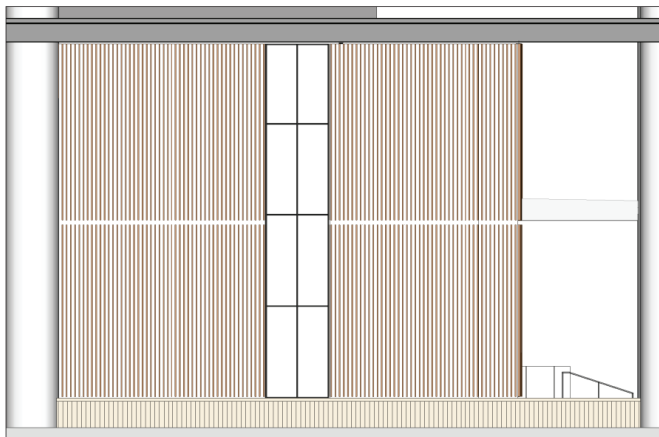


- Installation of a NOA compliant louver cladding system on the North, East and West façades of the building and porte-cochere ceiling

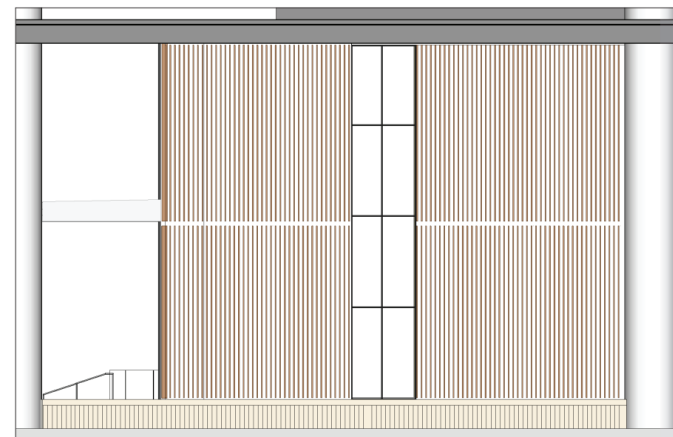
Building Façade and Arrival Entry - Proposed

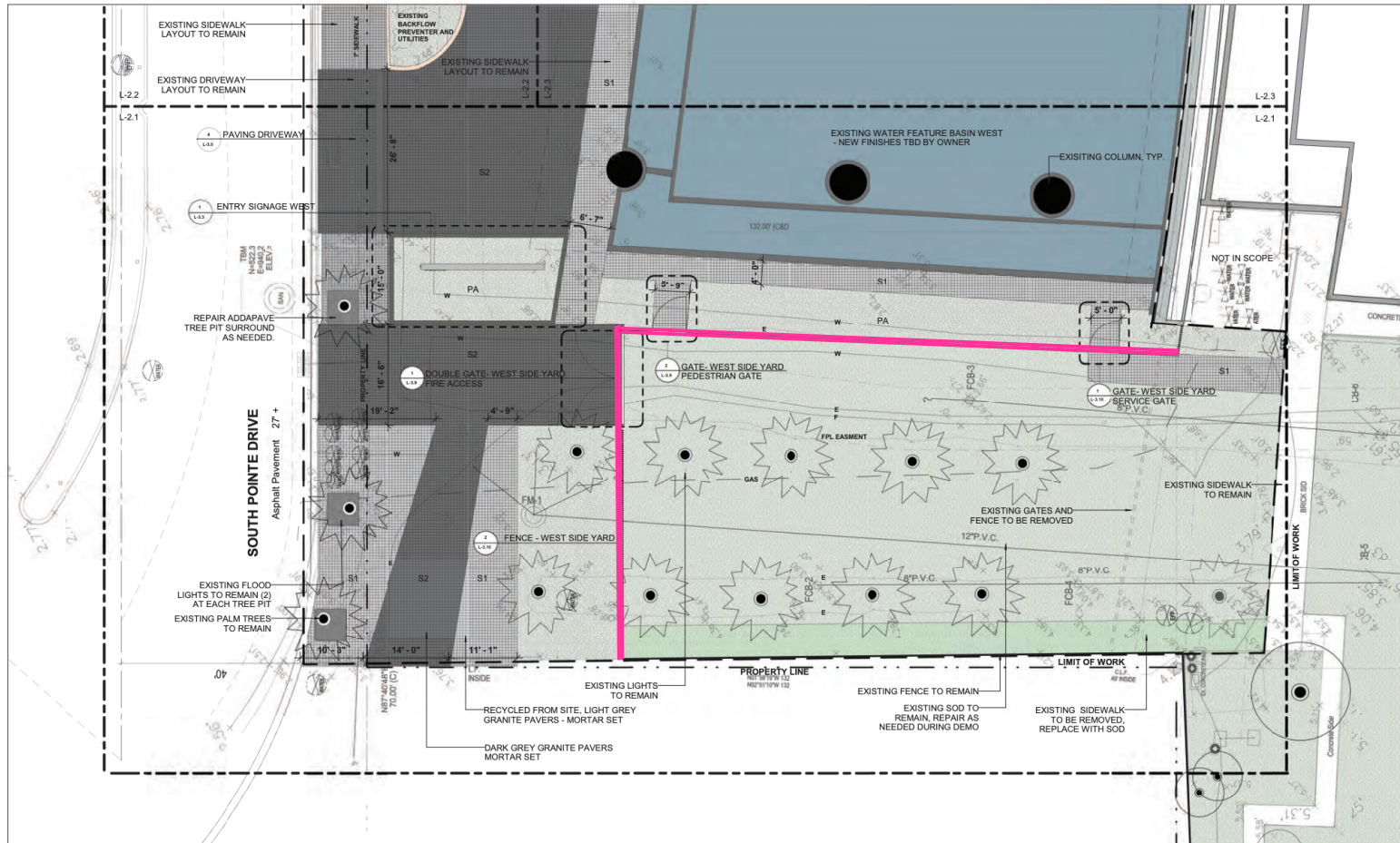

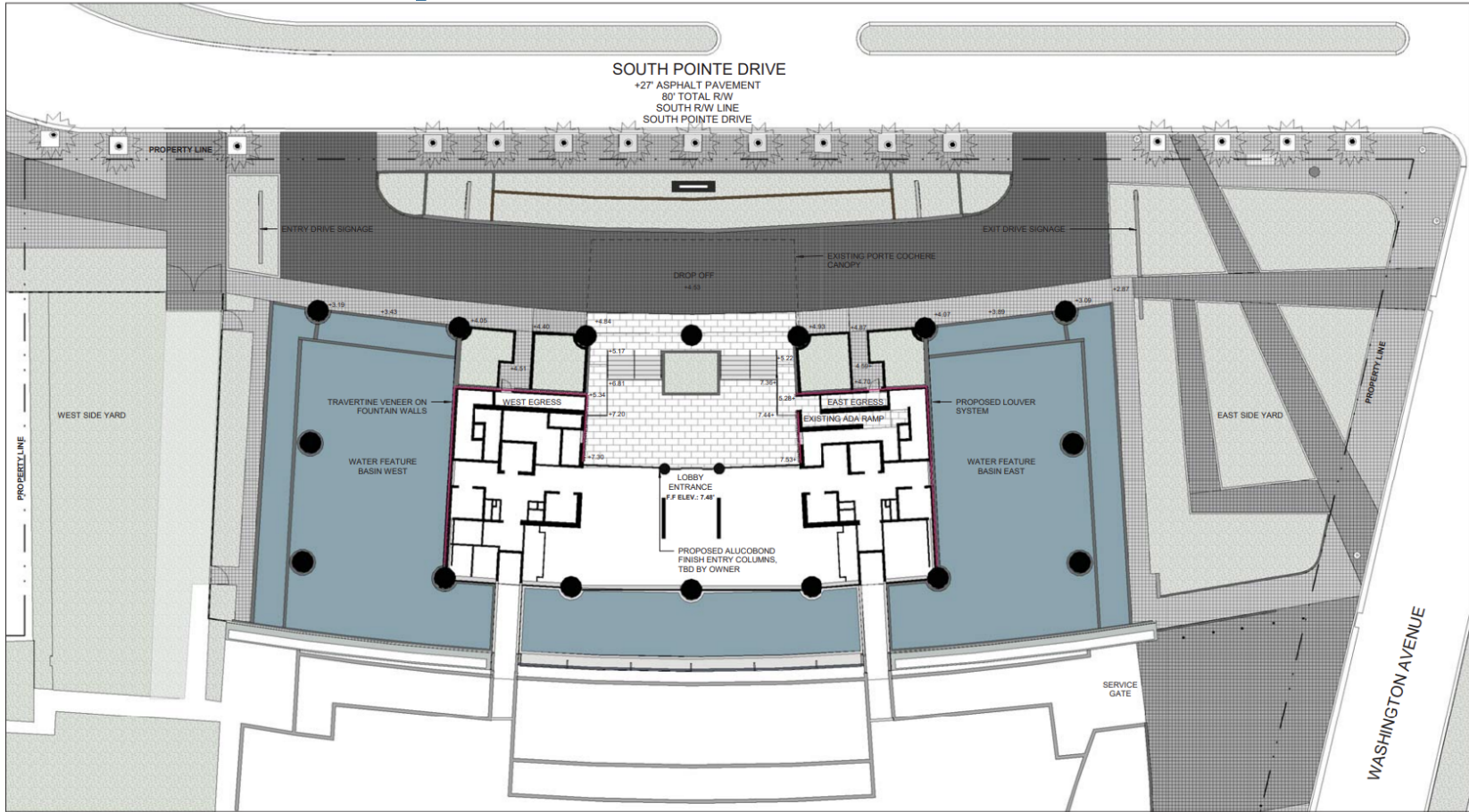
- Proposed gate and fence aligned with the existing entry water feature for enhanced security and creates an enclosed area suitable for dog walking and children's play.
